### Message from the President

Dear Friends,

In Bordeaux, the Executive Committee of our Association will be – at least in part – renewed. Han van Krieken will complete his Treasurer/Secretary mandate and I will be substituted by Philip Kluin. I wish to express my own and all EAHP members' gratitude to Han for his great and long service. If our Association is in a good stand, this is largely due to him. I wish to also thank Elias Campo for his excellent job as Meeting Secretary (that he will continue during the next presidency) and all the members of the Executive Committee who greatly contributed with their ideas and enthusiasm. Antoine De Mascarel merits a special mention for the organisation of the next Meeting in Bordeaux that - I am sure – you all will attend and contribute to make a great success: this will be the best reward for all the efforts made, time devoted and energies generously spent by Antoine. Last but not least, I wish my dear friend and successor Philip a very successful Presidency of our Association that he will be certainly improve.

I have had the chance to serve as EAHP president after Miguel Piris, who initiated its transition, to a more professional format. During the last two years, some steps have been made in such direction. The web-site we have in common with the Society for Hematopathology, our sister in the United States of America, has been improved. The Atlas on reactive and inflammatory lymphadenopathies, a masterpiece created by Karl Lennert and Jacques Diebold, has become available on the web-site, where you can also find a new discussion board. Haematologica/The Hematology Journal became the official Organ of our Association and a position of Associate Editor was attributed to an EAHP member, Elias Campo at the moment. At the same time, Han van Krieken has founded the Journal of Hematopathology that generously will give hospitality to the Abstracts of the Bordeaux Meeting (the first issue is now available at <http://www.springer.com/medicine/pathology/journal/12308>). The EAHP Executive Committee is following this initiative with great attention for possible future closer cooperation. Importantly, the relationships with the Society for Hematopathology have further been strengthened. This ensued in the joint management of the WHO Classification that represented a tremendous effort, and that hopefully will have the same impact as the third edition had. It's nice to read in the Blue Book introduction what follows: "The World Health Organization (WHO) Classification of Tumours of the Haematopoietic and Lymphoid Tissues (4th Edition) was a collaborative project of the European Association for Haematopathology and the Society for Haematopathology".

In addition, the relationships with the European Haematology Association, European Society of Pathology and International Academy of Pathology have been improved with invitation of our Association to organise sessions and workshops of their Congresses or to candidate *ad hoc* speakers.

Several Meetings have been held under the auspices of or in co-operation with the European Association for Haematopathology in different Countries and Continents (from Spain to USA, Mexico and Uganda), all resulting in great successes. Intentionally, I wish to separately remind the Meetings and Workshop organised by the European Bone Marrow Working Group. This is a very dynamic branch of our Association which pursues our scientific and diagnostic activities in the field of bone-marrow pathology by achieving excellent results: I am very proud of it.

Finally, a negotiation has been initiated with the Kiel University to preserve Professor Lennert's personal archive. I volunteered to spend some weeks there in order to make a preliminary screening of the material available and it would be great that others would follow me to complete the job. This will be my last service in the EAHP name.

I am indeed aware of the fact that my activity didn't suffice to all the needs of our Association. This reflects the limitations of the human being with the ensuing discrepancy between intentions and actions. I have tried to do my best and feel indeed honoured to have served the European Association for Haematopathology. I do hope that you haven't too many complains: in any case, I am the only one responsible, the Executive Committee members having served above themselves.

## In memoriam David York Mason (1941–2008).

### David York Mason (1941–2008).

Professor David York Mason, who died prematurely on 2nd February 2008, was an internationally renowned authority in the field of human lymphoma and leukaemia. He made numerous contributions to the development and practical use of monoclonal antibodies which determined the direction of modern haematopathology and laid the foundations of the classification of lymphoma and leukaemia we use today. He was also a wonderful teacher who influenced many top scientists and doctors and a true intellectual with a wide knowledge of other fields, including art and literature. He described himself as a *free spirit*: certainly he had an enormously generous spirit, and great compassion for those in difficult circumstances.

One of his last intellectual efforts was writing the chapter on ALK negative anaplastic large cell lymphoma for the upcoming World Health Organization (WHO) lymphoma classification, which he completed just before his final illness. One striking feature about David's career was his enthusiasm for international collaboration and his openness to the ideas of others. He traveled widely and always welcomed foreign visitors to his laboratory.

David's facility for languages (he was fluent in Italian and French) and his wide cultural interests helped foster this extraordinary network of international collaborators who were later among the founding members of the International Lymphoma Study Group (ILSG). David was to be the host of the International Lymphoma Study Group annual meeting in Oxford in June this year, but his untimely death forced a change of venue. We will miss his insatiable curiosity, his acute observations, and his cheeky school-boy smile, but his spirit will live on.

**9th International Course on Bone Marrow Pathology, Geneva, Switzerland May 7-9, 2009**

9th International Course on Bone Marrow Pathology will be held close to Geneva, in Western Switzerland, close to the Alps and to the lake.

The course continues the tradition of bi-annual tutorials organized by the European Bone Marrow Working Group (previous: 2001 – Palermo, 2003 – Hannover, 2005 – Krakow and 2007 – Graz).

This is an advanced course for specialists and residents interested in bone marrow physiology and pathology. Before the course itself, a half day course on best practices in diagnostic methods will be held. The Course will extend over three days (Thursday – Saturday, May 7-9 2009) and will be conducted by internationally recognised specialists in bone marrow physiology and pathology. Like in the previous courses, the number of participants will be limited. There is no separate registration for the preliminary workshop on best practices and the Bone Marrow Pathology Course.
